Definitions



- The term "missing child" refers to a person:
 - Younger than 18 years old
 - Whose whereabouts are unknown to his parents, guardian, or responsible party.

 The missing child will be considered "at-risk" when one or more of these unusual circumstances are present:



- 13 years of age or younger
- Believed to be one or more of the items below:
 - Out of the zone of safety
 - Mentally diminished
 - Drug dependant
 - Potential victim of foul play or sexual exploitation
 - In a life threatening situation
 - Absent from home for more than 24 hours
 - · Believed to be with others who could endanger them
 - Absent under circumstances inconsistent with established patterns of behavior

LOST CHILD SEARCH STRATEGY

The Missing Child Search



- Hasty search of all likely areas.
 - House and Place Last Scene (PLS)
 - Parks
 - Vacant Lots
 - Water attractions
 - Pools
 - Streams, rivers or waterways
 - Storm drains

The Missing Child Search



- Open space areas
- Stores
- Door to door
- Investigation
 - Family
 - Friends
 - Runaway?
 - School or day care
 - Public transportation

Lost Child, Possible Abduction



- Does the child know the area, or could they be lost?
- Thorough search of the area with no clues or leads
- Evidence or leads that lean toward an abduction possibly
- Thorough investigation yields no clues
- DO NOT switch to abduction search strategies until you have ruled out that the child could be lost.

Search Strategies



- Searchers must either rule out that the subject is lost, or must conduct a through missing person search before implementing an abduction search.
- 2. Search area in a abduction search is much larger than a search for a missing person.
- 3. To conduct an effective search a large number of resources and the ICS system are required.

Search Strategies



- 4. SAR personnel should work with local Law Enforcement to define the area based on the Abduction Profile.
- Personnel should use abduction search tactics to define the search area and carry out the search.
- 6. Once a case is determined to be an abduction is that searchers are looking for a body dump and crime scene, often along or near a remote section of the road.

Search Strategies



- Deploy Ground and Canine Teams
 100 to 300 feet from roadways adjacent to fields, vacant lots, and other areas that might conceal a crime scene.
- Teams should be given specific
 assignments like searching every pullout
 to 300 feet along a county road. If there
 isn't room to park, don't bother
 searching the area.
